MAYOR/BOARD OF ALDERMEN COMMUNICATION. Alderman Skaggs reported that there is a public auction in St. Louis that has a used Street Sweeper for sale and wondered if it would be in the City's best interest to at least look into the equipment at the auction. City Attorney Frank Elpers said that it would require a Resolution passed by the Board of Aldermen before the auction date authorizing the City Administrator to spend up to a certain amount of money towards the purchase of the street sweeper. Alderman Okenfuss asked the Mayor about a letter that the City had received from the Corp of Engineers regarding the Corp of Engineers admitting some sort of guilt. Mayor Greminger reported that the City did receive a letter from the Corps of Engineers supporting a change in the funding formula that the City is seeking for the projects. The original plan was for the projects to remedy flooding from the North and South Gabouri Creeks to be funded 75% by government and 25% by the City of Ste. Genevieve. The City has three million in savings for what we thought would be plenty for the City's match but the Corps anticipated costs have risen. City officials are seeking a change to the funding formula where the City would pay only a 10% match.
