Minutes of the Ste. Genevieve Board of Aldermen Regular Meeting October 10, 2013

CALL TO ORDER. The Regular Board of Aldermen Meeting was called to order by Mayor Richard Greminger at 7:00 p.m. and all stood for the Pledge of Allegiance.

APPROVAL OF AGENDA. A motion by Alderwoman Zerwig, second by Alderman Donnie Stuppy, to approve the agenda as presented. Motion carried 7-0-1 with Alderman Couch absent.

CITY ADMINISTRATORS REPORT. (See Attached Report) Mr. Toma reminded the Board of Aldermen about the drainage issue on Tenth Street that was discussed at the prior meeting and that he would like a recommendation of whether or not to proceed with digging out the roadside ditch on the East side of Tenth Street. (Lucent Windows property) At this time discussion occurred regarding the area in question. Mr. Toma once again explained that since the area in question is on private property that the Board must be able to justify that it is in the public's best interest for the City to clean out this ditch. A motion by Alderwoman Zerwig, second by Alderman Donnie Stuppy to have the City Public Works to clear the ditch out along Tenth Street which is on Lucent Windows property. Motion carried 5-2-1 with Alderman Ross and Alderman Okenfuss casting the "No" votes and Alderman Couch absent.

AN ORDINANCE OF THE CITY OF STE. GENEVIEVE. BILL NO. MISSOURI AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT FOR PROFESSIONAL ENGINEERING SERVICES FOR WATER MAIN REPLACEMENT WITH COCHRAN ENGINEERING OF UNION, MISSOURI. 2nd READING. Mr. Toma explained that the contract with Cochran Engineering has had some revisions concerning the Limit of Liability. A motion by Alderwoman Zerwig to table this issue to allow more input from Citizens failed for lack of second. A motion by Alderman Okenfuss, second by Alderman Ross, Bill No. 3945 was placed on its first reading, read by title only, considered and passed with an 6-1-1 vote of the Board of Alderman with Alderwoman Zerwig casting the No vote and Alderman Couch Absent.

Stuppy, Bill No. 3946 was placed on its first reading, read by title only, considered and passed with an 7-0-1 vote of the Board of Aldermen with Alderman Couch Absent. A motion by Alderman Jokerst, second by Alderman Okenfuss to

proceed with the second and final reading of Bill No. 3946. Motion carried 7-0-1 with Alderman Couch Absent. A motion by Alderman Ross to approve the second reading contingent upon Missouri Petroleum repairing all the issues in the downtown area from the last contract first, and then proceed with this contract for the Fourth Street Micro-Sealing, second by Alderman Donnie Stuppy. Bill No. 3946 was placed on its second and final reading, read by title only, considered and passed by a roll call vote as follows: Ayes: Alderman Okenfuss, Alderwoman Brumfield, Alderman Donnie Stuppy, Alderman John Stuppy, Alderman Ross, Alderwoman Zerwig, and Alderman Jokerst. Nayes: None Absent: Alderman Couch. Motion carried 7-0-1. Thereupon Bill No. 3946 was declared Ordinance No. 3886 signed by the Mayor and attested by the City Clerk.

GENEVIEVE, MISSOURI FOR PORTIS STREET IMPROVEMENTS PROJECT. 1ST READING. A motion by Alderwoman Zerwig, second by Alderman Ross, Bill No. 3947 was placed on its first reading, read by title only, considered and passed with a 7-0-1 vote of the Board of Aldermen with Alderman Couch Absent.
